- I shall be required to appear before the board of Directors with my application in order to be considered for membership. (the Board meets at 7:00 pm on the last Wednesday of each month).
- I shall be accepted on a probationary basis only, for a period of ninety (90) days. During this period, I must attend at least two (2) club functions and introduce myself as a new member to a Club officer at each of these functions.
- Further, I understand that the Board may terminate my membership at its sole discretion should I disregard club rules, damage club property, act in an unsafe manner, act against the interests of the club, or conduct myself in an inappropriate manner.
- As a member, I agree to sign in and out on the Club's log book upon entering and upon leaving the club property. If I am the last person to sign out, I will make sure the entrance gate to the property is properly locked.

Before I am permitted to use the shooting range facilities, I shall be required to attend an orientation meeting and demonstrate a thorough knowledge of safe firearms handling.

- If I cannot demonstrate such knowledge to the satisfaction of the orientation officer, then I shall be required to enroll in and show proof of completion of an NRA Basic Firearms Safety Course. These courses are conducted, for a fee, by one of the Club's instructors. Alternatively, I may seek instruction elsewhere.
- I have read and understand the above terms and conditions for membership and agree to carry them out within the limits of the Club's bylaws.
